DECLARATION

I,Parent/Guardian of
..... do hereby
understand and accept the following fully :

- a) To abide by the decision taken by the Hostel Authorities for any misbehavior, insubordination, political involvement, unruly behavior towards the hostel in-charge and other executive staff .
- b) I undertake to abide by the rules and regulations of the Hostel, the violation of which will subject me to Fines / Suspension etc. as decided by the authorities.
- c) I shall not plead ignorance of any rules that may be notified from time to time.
- d) I undertake not to stay away from hostel without prior permission or adequate information. Such an act can lead to disciplinary action against me including expulsion from the Hostel/ School.
- e) I will not hold the authorities responsible for injuries / death of my ward that is accidental by nature.
- f) I will not hold the authorities responsible should my ward break bounds and abscond from the hostel and fall into any danger as a consequence. I will withdraw my ward should he / she abscond from hostel, failing which the authorities are at the liberty to expel my ward and I will pay all the dues.
- g) In case of any accident or illness the Hostel Authorities may take the child to the Hospital/ Nursing Home as per the condition of the child.
- h) I certify that the above information is correct and affirm that I will abide by the rules and regulations set by the Hostel which is clearly mentioned in the Prospectus.
- i) No gold or other jewellery or expensive items will be given to my child.
- j) No money will be sent by postal envelopes /M.O./ Cheque/ Draft or Courier to my ward directly.
- k) Only the specified pocket money will be given, the school reserves the right to confiscate amounts in excess of the prescribed limit.
- l) I and my child /ward undertake not to gain special favours or advantage from any member of staff or employee by giving gifts in cash or kind.
- m) No distressing news will be given directly to my child /ward by me. I will intimate the Principal if the need arises.
- n) I undertake to pay the necessary late fines in force at the time of my child / ward's late arrival to school after any holiday.
- o) My child has my permission to travel by himself for any holiday, when the students are required to leave the school.
- p) I hereby state and declare that should I or my child /ward not fulfill any one of the above conditions fully or partially or have furnished false documents or incorrect information, then the authorities of Rockvale Academy have the right to strike off the name of my child / ward from the school rolls and my child / ward will be considered withdrawn from the school by me.
